Renter Information

It is the **owners' responsibility** to provide the HOA with all names and exact lease dates and contact information of renters residing at your property. If you have hired a property management firm, please also include their name and contact information. Policy regarding the transferring of recreational privileges states: Hethwood Foundation recreational privileges lie solely with the deeded owner(s) of the property. If the owner does not live on the property, they *may* transfer their privileges to residents living in their property. The owner must notify the Hethwood Foundation office *in writing* of their intention to allow the current resident(s) to use the privileges. The owner then forfeits privileges to the renters. Please note: If a homeowner wishes his/her renter to have access to the fitness center, the owner must transfer his/her own fitness center key or have his/her management company sign on his/her behalf for return responsibility of the key.

Pool Opening Information: Depending on lifeguard availability and weather permitting, we anticipate opening the **Briarwood and the Huntsman pools** on the following pre-season weekends: May 17th -18th, May 24th-25 & Memorial Day the 26th - regular hours.

The following regular season hours will begin on May 31st.

Briarwood Pool: 12pm to 8PM daily (w/lap swim M-F 11am-12pm) Huntsman Pool: 11am-6pm daily

Pool pin registration will be held @ the Huntsman clubhouse on the following dates:

Wednesday & Thursday, May 14th & 15th from 5:45pm - 7:45pm

**Please plan to attend on one of these dates if pins are needed in your household.
After this date and prior to the 27th pool pins can be picked up at the Briarwood pool.**

Please note that Hethwood dues (due on May 1st) must be paid prior to pool registration. To maximize staff during office hours, we strongly encourage pool pin registration be accomplished at the Huntsman clubhouse while extra staff is available. After May 27th pool pins can be picked up at the *Huntsman pool after 12:00pm*. Pool pin registration is only necessary for:

1. **Persons 16 years or younger that do not have a picture ID or driver's license.** One adult per household should come by, fill out registration forms and pick up the children's pins. Initial pins are free; however, replacements for lost pins will cost \$2.00, which is nonrefundable.
2. **Adults that do not have a picture ID. Please note that a picture ID may be obtained from the Virginia DMA** list of residents will be kept at the pool gate. Adults over 16 years are **REQUIRED** to show a photo ID to enter the pool. If you have any questions concerning the above, please call 552-5252.
