1. **HUNTSMAN POOL HOURS:** Monday - Saturday 10 am to 8 pm & Sunday 12 pm to 8 pm (Lifeguards on Duty)

QUAD POOL HOURS: Monday - Saturday 10 am to 8 pm & Sunday 10 am to 8 pm (NO Lifeguard on Duty)

HETHWOOD OFFICE HOURS: The office is located on the second floor of the 100 building above the Foxridge Welcome Center. The office is open weekdays Monday through Friday 8:30 am to 5:30 pm and closed daily from 1 pm to 2 pm. In the execution of property-related duties, our team may need to step away from the office periodically. A phone call ahead will allow us to better serve you.

2. **RESPONSIBILITIES OF MANAGEMENT AND RESIDENTS**

All persons using the pool or pool area do so at their own risk and sole responsibility. The management assumes no responsibility for any accident or injury in connection with such use. Persons using the pool covenant agree with the owner or management to make no claim against the owner or management for, or on account of, loss of life or personal injury or damage to or loss of personal property.

3. **IDENTIFICATION**

All residents are to show a picture identification card when entering the pool area. It is our policy to ask everyone for proper identification, even if we know you. This is done to establish residency, treat everyone equally, and satisfy Fair Housing requirements. Please have your ID ready when being admitted to the swimming pool. Any person not having a picture ID, will be issued a pool pin. Pins are to be worn at all times upon entering the pool area. Initial pins are free; replacement pins (nonrefundable) may be purchased for \$2.00. Pool pins will be available at the Quad pool and then only at the Huntsman Pool when it opens for the season.

4. **GUESTS**

All guests must be accompanied and registered by a resident. Residents will be allowed to entertain up to three guests on any one day. Conduct of the guest is the direct responsibility of the resident. Guests are subject to the rules that apply to residents. Guest fees are **\$5.00** at the pool gate. Guests 2 years and younger are free. Exact change at the gate is requested.

Yellow Pass

- Yellow discounted guest passes are **\$3.00** each and must be *pre-purchased* at the Hethwood Foundation office (see hours above).
- Residents may purchase as many yellow passes as wanted throughout the current season.
- The yellow pass is valid for one visit per one guest during the current season.

Orange Pass

- Orange discounted guest passes are **\$3.00** each and must be *pre-purchased* at the Hethwood Foundation office (see hours above).
- Allows for one resident to entertain up to 6 guests pending availability of lifeguards.
- This pre-purchased pass requires a designated date and may only be used at the Huntsman.

If pools close early (for weather or other unscheduled closing) within two hours of entry on a guest pass, the resident will be credited a replacement pass (see lifeguards). Passes will only be valid for the current season. No refunds will be given if passes are not used during the current season. We cannot be responsible for the weather or seasonal lifeguard availability. Passes will not be accepted on July 4 & certain special events.

5. **POOL SUPERVISION**

The pools will be in the charge of a qualified head lifeguard or attendant who will be under the direct supervision of the management. ***The pool staff has the authority to suspend any resident's swimming privileges due to rule, regulation, or policy violation.*** (The suspension period may vary with the severity of the violation). Pool staff may request a swim proficiency test at any time. The Huntsman pool is staffed with certified lifeguards (unless otherwise posted). The Quad pool does not have a lifeguard on duty and is staffed by a supervising attendant.

6. **SUPERVISION OF Residents and Guests under 16 years of age:**

- Caretakers must be 16 years or older. Caretakers registered through the Hethwood Office will not be charged a guest fee unless another adult from that family comes to the pool.
- Residents and Guests younger than 4 years may use the wading pool only when accompanied and supervised by an adult/guardian or caretaker.
- Residents and Guests 10 years and younger must have an adult/guardian or a caretaker at least 16 years to be permitted entry to the pool/building areas.

- Residents and Guests 11 and 12 years may come to the pool unaccompanied by an adult, provided they pass the swim test (*must be able to swim 25 meters with good form and tread water for 1 minute*). Parent/Guardian must be present while lifeguard administers test, and both must sign proficiency form. The swim proficiency test is administered at the Huntsman pool only.
7. **UNAUTHORIZED ENTRY**
Swimming is permitted only when the pool is open. Violators will face disciplinary action by management.
8. **PRIVILEGES**
If a resident is delinquent in the payment of rent, late fees, damages, or dues, pool privileges will be suspended. Residents that are not in good standing may not use the facilities *or be a guest* under any circumstances.
9. **PROPERTY DAMAGE**
The cost of any damage will be charged to the responsible party. Management cannot be responsible for loss or damage of any kind.
10. **USE OF LIFE PRESERVERS, ETC.** Artificial flotation devices (water wings, inner tubes, pool noodles etc.) may not be used at any time. U.S. Coast Guard-approved personal flotation devices (PFDs) may be approved by consulting with a lifeguard. Flotation swimsuits may be used only if the brand is U.S. Coast Guard approved.
11. **CLOSING OF THE POOL**
The pool may be closed at any time due to inclement weather, equipment breakdown, or other operational difficulties.
12. **DIVING RULES** – equipment at the Huntsman pool is strictly for use at your own risk.
 - Only one person may be on the diving board at a time.
 - Diving is **ONLY** permitted straight away from the board. No diving toward the walls will be permitted.
 - **No specialty dives.**
 - Upon completion of the dive, swim to the nearest ladder IMMEDIATELY. Do not swim under the boards.
 - In the interest of the majority, and at the sole discretion of the lifeguards, the diving boards may be closed.
 - Diving is prohibited at the Quad pool.
13. **FOOD, BEVERAGES & SMOKING MATERIALS**
No intoxicants may be brought into the pool area. No food or drink will be consumed in the immediate apron portions of the pool area. Trash and refuse must be placed in the receptacles provided; please recycle. No glass or other breakable objects will be allowed. Coolers may be checked for contents of glass or intoxicants. **Smoking or vaping is prohibited in designated amenity areas. This includes the fenced areas of the pool and courtyard.**
14. **RULES CONCERNING HEALTH & RESTROOMS**
 - Restrooms will be open during pool operation.
 - Before entering the pool, all bathers must take a cleansing shower.
 - Admission will be denied to anyone with skin abrasions, colds, coughs, inflamed eyes, infection, or anyone wearing bandages. Bathers should impose this responsibility themselves, but if in doubt, consult the lifeguards or attendants.
 - Swim diapers must be worn by any bather who is incontinent, lacks toilet training or is otherwise deficient in voluntary control of excretory function.
 - Pollution of the swimming pool is prohibited. Urinating, discharge of fecal matter, expectorating or blowing the nose in any swimming pool is prohibited.
 - All pool patrons must adhere to posted COVID-19 guidelines and recommendations made by the Centers for Disease Control and Prevention (CDC).
15. **DRESS**
All bathers must wear appropriate swimming attire (bathing suit or wetsuit). Dripping bathing suits in the building areas must be avoided! ***Cut-off shorts and other street apparel will not be allowed in the pool.*** Bathers must wear fully opaque coverings (refer to Town of Blacksburg Code Section 14-108). Thongs are prohibited.
16. **PETS**
Pets are not allowed in the pool area. Pets may not be tied to trees, fences, or other structures in the Hethwood common area outside of the pool.
17. **WHEELED RECREATION VEHICLES**
Wheeled recreation vehicles, skateboards, rollerblades, or skates of any type will not be allowed in the pool area. Wheelchairs and strollers are permitted.
18. **PHONES**
Emergency 911 phone devices are available and posted with signage at each pool deck location in the event of an emergency.
19. **REVISION OF RULES**
These rules may be revised, or additional rules established, at any time. Please ask the office or lifeguards for a listing of additional pool policies and basic lifeguard guidelines. Questions regarding conduct or pool rules should be addressed to the Head Lifeguard or Management.
